## Updates

Aaron gave an update on the printer that is still giving issues with getting supplies as needed and the payout is over \$6500.00.

## Old Business

Mayor Almond said with the much higher cost than expected for the roof to be replaced on the front storage room she suggested to the remove the storage room and place a simple cover over the porch area.

Commissioner Almond said that the removal of the room could easily be done by board members and should only take a few hours to take down. The other commissioners like the idea as well.

Aaron said that the latest update on the playset showing up is putting it around Christmas to New Year's weeks showing up.

Once it shows up it will be installed they said it in 2-3 days depending on the weather. Aaron requested that a budget amendment be made to ass GL code for ARP fund usage and that

\$35000.00 be placed in the line item to pay for the remaining part of the playset and cover future sets.

A motion was made by Commissioner Almond to approve the budget amendment to use the purchase of playground equipment with the ARP funds in the amount of \$35000.00. Second by Commissioner Reavis 4-0
