Interim Chief Shuping present to the board a what if case if the state does not approve Mr. Poteat to be the new chief of police. In the break down it would be giving officer Hill a raise of \$18.00-\$20.50 a hour and cutting the chief pay rate down to \$17.50 and leaving it at 40 hours for a two week time frame. Aaron did say that the saving of \$9578.46 would be cut into almost half as not all accounts for the full time officer wasn't on the print out.
